





Whereas the Trustees have consented and agreed to act as Trustees under this Trust,

Now This Deed of Trust Witnesseth as follows:-

1. Name of the Trust: This Trust shall be called Bangalore South Welfare Trust.
2. Registered Office: The Registered Office of the Trust, for the time being, is at No.215, First Block, Koramangala, Bangalore 560 034.
3. Aims & Objects:
 - (a) To promote unity amongst General Public with a view to build a healthy and strong Nation and create friendship, goodwill and mutual trust.
 - (b) To establish Orphanages with an aim to board, lodge, cloth and educate the needy Muslims Orphan Boys and Girls, establish rehabilitation centres, hospitals, dispensaries, after-care units, schools, adult education centres, vocational and technical training institutes, libraries and Baithulmals in and around Bangalore.

(c) To assist, support and supplement and activities of the Sub-Committees formed by the Trust to achieve the above objects.

(d) To promote, organise and subsidise relief and welfare activities.

(e) To protect, espouse and represent the interests of the Muslims.

(f) To seek the cooperation and assistance of Muslim States, National Governments, National and International Organisations in the promotion of the activities, aims and objects of the Trust.

(g) To uphold the dignity of man to work for the implementation of social justice and to foster love and unity amongst Muslims and all people.

(h) To assist financially, socially and otherwise needy Muslims.

4. Financial Resources:

(a) Acquire by purchase, lease, mortgage, get loans, gifts, grant legacies, bequest, exchange, right, privilege or otherwise from any person, company, society, Government, Institution or Organisation (Local or Foreign) or anybody howsoever, movable or immovable properties of all descriptions deemed necessary or useful for any purpose of this Trust.

(b) Open, establish, conduct, maintain, manage, equip, close down, dispose of or deal with any of its Madarasas, Hospitals, Dispensaries, Schools, Libraries, Technical and Vocational Institutions and training centres and Baithulmalls.

(c) Erect buildings or structures to further any purpose of the Trust and maintain, develop, improve, alter, repair, demolish or reconstruct the same or any portion thereof.

7. The Office of the Trustees as well as those on the Advisory Boards and the Managing Committees shall be honorary and none of them are entitled to any remuneration whatsoever for carrying out their duties.
8. Any Trustee of the Trust who becomes a bankrupt, lunatic, convicted, of a criminal offence, involving moral turpitude or neglect to take interest continuously for a period of more than six months or physically incapacitated for a period considerable or remains outside India without the written permission of the Board of Trustees for a year and more, such Trustee shall cease to be a Trustee of the Trust.
9. Any Trustee may retire on giving one English Calender month's notice in writing to the Board of Trustees of his intention to do so, in advance.
10. All deeds and other documents to be executed by or on behalf of the Trust shall be done by the Chairman of this Trust.
11. The Trustees are wholly indemnified against any expenses and losses incurred or suffered or any payments made by them in the administration of the Trust and such expenses, losses and the payments shall be borne by the Trust and none of the Trustees shall in any manner be personally liable or responsible for the same.
12. The Trustees may reimburse themselves or discharge out of the said Trust Properties all expenses incurred in or for the execution of the objects of the Trust and in exercise of the powers vested in them.
13. The Trustees shall act jointly and should any difference of opinion arise at any time amongst them in relation to the doing or for bearing to do any thing or otherwise, the opinion of the majority shall prevail and be binding and shall effectually be carried out.

14. The Board of Trustees may delegate any or all their powers to anyone or more of them and for such time and purpose as they deem fit.

15. This Trust shall be a Private trust in the sense that it will not now or in future, be a wakf trust and thus excluded from the purview of the State or General Wakf Act 1954.

16. Board of Trustees.

There shall be Seven Life Trustees only who will manage this Trust.

The following shall be the Founder Life Trustees and shall continue as Board of Trustees during their lifetime or till they voluntarily resign or till removal for reasons stated in this Deed.

171 In the event of death or voluntary resignation, or removal for reasons stated in the rules herein, of any trustees, the remaining members of the Trust shall select a Muslim from Bangalore or surroundings, to fill the vacancy by a two-third majority.

18. Functions:

(a) Chairman:

He shall preside over all the meetings of the Board of Trustees.

He, along with the Secretary shall operate on the Bank Accounts as joint signatories.

He will exercise his utmost care and diligence to see that all contributions, cash or kind, any gifts, grants-in-aid from any source, or from local bodies or private organisations received for the orphans or orphan destitutes are expended only for that purpose and under no circumstances will be utilised or permitted to be utilised by the Board of Trustees to divert such donations, contributions, gifts grants-in-aid for other purposes.

He shall supervise all the affairs of the Trust, in general.

He shall periodically inspect and make surprise visits to all the Institutions managed, owned and run by the Trust and scrutinise the budget, accounts and other documents and all financial statements of the Trust and its allied institutions.

He shall have a second or casting vote. He shall act individually as the Chairman or with the assistance of any other Trustee.

(b) Vice-Chairman:

In the absence of the Chairman, the Vice-Chairman will perform all the duties and functions of the Chairman, except operation of bank accounts.

He shall assist the Chairman in his duties.

Whenever required by the Chairman to act for him regarding all or any of the functions of the Chairman, he shall delegate such functions to him, except the operation of the bank accounts.

He shall periodically inspect and make surprise visits to all the institutions of the Trust and report the matter to the Chairman.

He shall keep a vigil over the donations and contributions and see that no donations, contributions, gifts, grants-in-aid, or other financial sources received for the orphans and orphan destitutes are expenced only for that purpose and under no circumstances will permit the Board of Trustees to divert such contributions, donations etc., for other purposes.

(c) Secretary:

- (1) The primary duties of the Secretary shall be to duly carryout the resolutions passed by the Board of Trustees and for implementing the decisions and directions of the Board of Trustees.
- (2) He shall be in charge of and responsible for the safe custody of all records relating to the administration of the Trust and its properties.
- (3) He shall maintain a report of minutes of the proceedings and all meetings of the Trust.
- (4) He shall maintain a Register of the Trustees of this Trust and all committees appointed by the Trust.
- (5) He shall collect all dues to the Trust and remit them into the Bank.
- (6) He shall prepare the Annual Report of the Trust and of all committees appointed by the Trust.
- (7) He shall keep the entire staff under his direct control and supervision.
- (8) He shall properly maintain true and correct accounts of the Trust and sign the cash book and other records and affix his signature thereto.

- (9) He shall in consultation with the Chairman convene the Board Meetings atleast once a month.
- (10) Ordinarily all correspondence relating to the Trust shall be in the name of the Secretary of the Trust.
- (11) He shall perform all such other acts as are provided under this Trust and all such due duties as are incidental to his office.
- (12) He shall be responsible for the ordinary working of the Trust.
- (13) He shall institute, prosecute and defend civil and criminal suits and other proceedings in which the Trust may be a party.
- (14) He shall collect rents from the properties of the Trust and issue proper and valid receipts therefor under his signature, duly countersigned by the Treasurer and shall be responsible for recovery of all the amounts due and payable to the Trust.
- (15) He shall place all the matters pertaining to the Trust before the meeting of the Board for consideration and concurrence.
- (16) He shall give effect to the decisions of the Board.
- (17) He shall perform all such acts as may be deemed fit and necessary to his office or/and as may be decided by the Board from time to time.

(d) Treasurer:

He shall keep proper accounts of all the money received and disbursements made on behalf of the Board, its properties, and institutions and shall be primarily responsible for the safe custody of all the books of accounts, documents, vouchers and papers relating to the financial matters of the Board and its properties.

The Treasurer shall be responsible for all the monies and spent by the Trust.

19. Meetings:

(1) The Board of Trustees shall meet atleast once a month to transact the business of the Trust.

(2) A Special Meeting of the Board of Trustees may be convened at any time on the requisition of the Chairman or on the requesting by atleast five trustees of the Trust stating in writing the business for which they wish to call for the special meeting to be convened and the Board of Trustees, shall then within seven clear days from the date of receipt of the written requisition call a meeting for the consideration of the business.

(3) If within half-an-hour from the time fixed for the ordinary meeting and special meeting, the prescribed quorum be not present, the meetings shall be adjourned to some other date fixed by the Chairman.

11. Notice of Meetings:

(1) Notice of Meetings shall be sent as follows:-

In the case of the Board of Trustees Meeting:-

(a) Five clear days ahead to all the Trustees by post under certificate of posting or by hand delivery,

In the case of Special Meeting of the Board of Trustees if convened by the Chairman -

(b) Twenty-four hours ahead of the meeting either by hand delivery or over the Telephone.

(c) Except for adjourned meetings the Agenda shall always accompany the notice.

20. Quorum:

1. The quorum for the meeting of the Board of Trustees will be five for transacting ordinary business.

2. But if the matter for consideration relates to any of the Rules herein the quorum shall and will be the total number of Trustees less one i.e., if the total number of Trustees is seven, the quorum in such cases shall and will be six.

21. Committees:

The Board of Trustees shall appoint committee at any time to carry out any specific task, and the members of the Committee need not be Trustees of the Trust.

22. Alterations or Additions:

These Rules may be altered, amended, or added with any other Rule by the Board of Trustees.
